	PROVISION OF DATA
	Pursuant to Art. 13, para. 2, lett. e) of the GDPR, we inform you that the provision of the e-mail address for the aforementioned purpose is mandatory; therefore, any refusal to provide it will make it impossible to send you the Newsletter.

	CANCELLATION FROM THE SERVICE
	To stop receiving the newsletter, enter your email address in the appropriate box and click on the "Unsubscribe" button.

	DATA RECIPIENTS
	The data may be communicated to subjects acting as data controllers (such as, by way of example, supervisory and control authorities and any public entity entitled to request the data) or processed, on behalf of the Company, by persons designated as Data Processors, who are given appropriate operating instructions (such as, by way of example, companies that carry out the management and/or maintenance service of the Company's Website, Companies that perform the Newsletter sending and management service).

	SUBJECTS AUTHORIZED TO PROCESS
	The data may be processed by employees of the corporate functions responsible for the pursuit of the aforementioned purposes that have been expressly authorized to process and have received adequate operating instructions.

	RIGHTS OF THE DATA SUBJECTS - COMPLAINT TO THE CONTROL AUTHORITY
	By sending an e-mail to the address DPO@rhiag-group.com , data subjects may ask the data controller to access the data concerning them, their deletion, the correction of inaccurate data, the integration of incomplete data, the limitation of processing in cases provided by Art. 18 of GDPR. Furthermore, if the data processing is based on consent or contract and is carried out with automated tools, the data subjects are entitled to receive the data in a structured, commonly used and automatically readable format, as well as, if technically feasible, to transmit them to another controller without impediments.

	Data subjects have the right to lodge a complaint with the competent Supervisory Authority in the Member State in which they normally reside or work or in the State in which the alleged violation occurred.
